After a trial to the court, West Virginia Circuit Judge Martin Gaughan entered a 77-page decision awarding \$4,475,000.00 to the State. RAPTIVA Drug Alert. In 2003, the FDA approved Raptiva for the treatment of psoriasis. Then, on February 19, 2009 the FDA issued a Public Health Advisory warning of certain adverse events secondary to the use of Raptiva. These include life-threatening infections, such as bacterial sepsis, viral meningitis, invasive fungal disease and other opportunistic infections. An additional risk is the rare and usually fatal condition called progressive multifocal leukoencephalopathy (PML).
